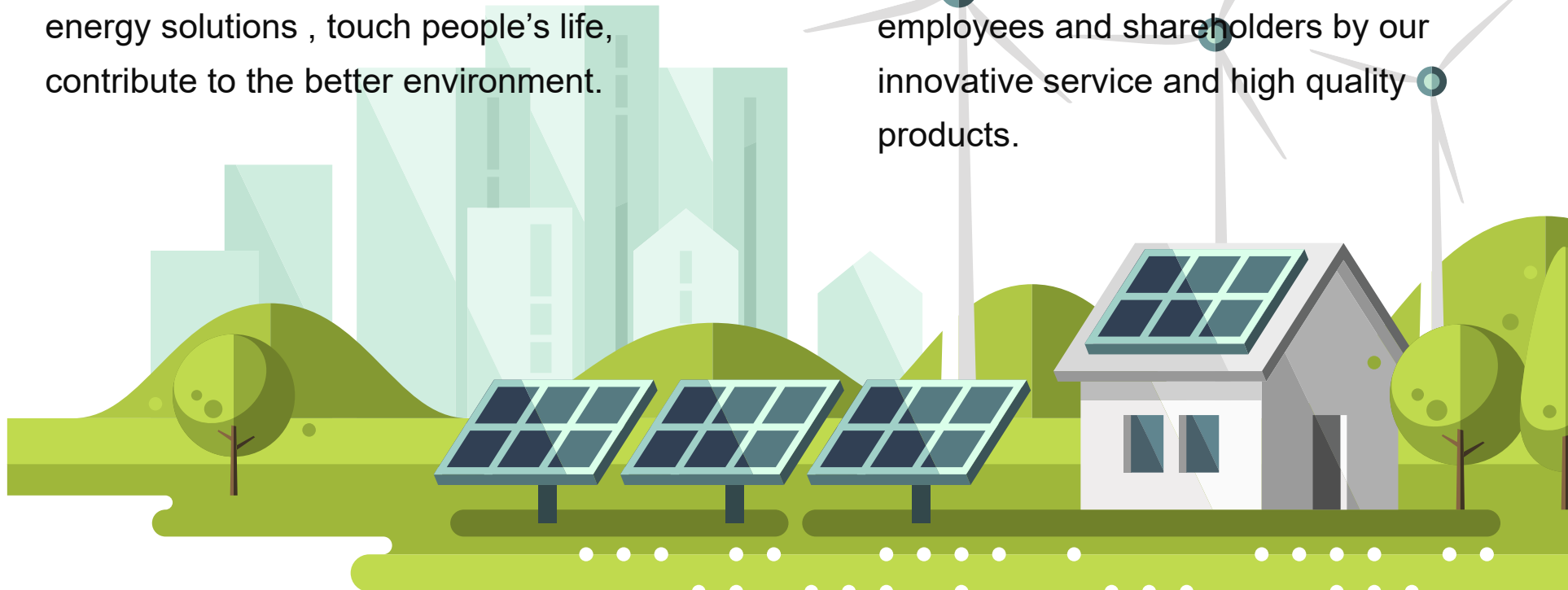

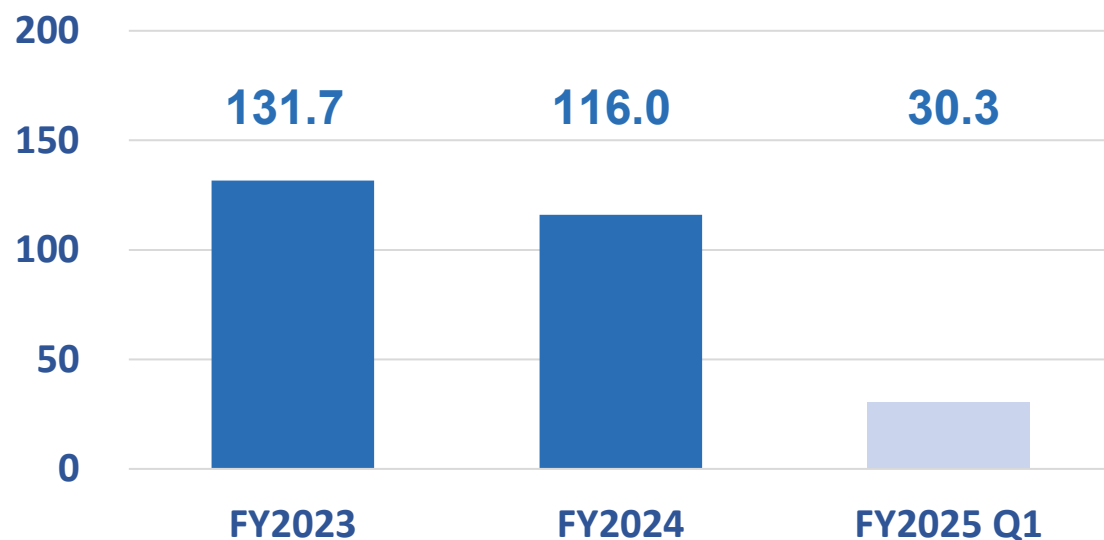

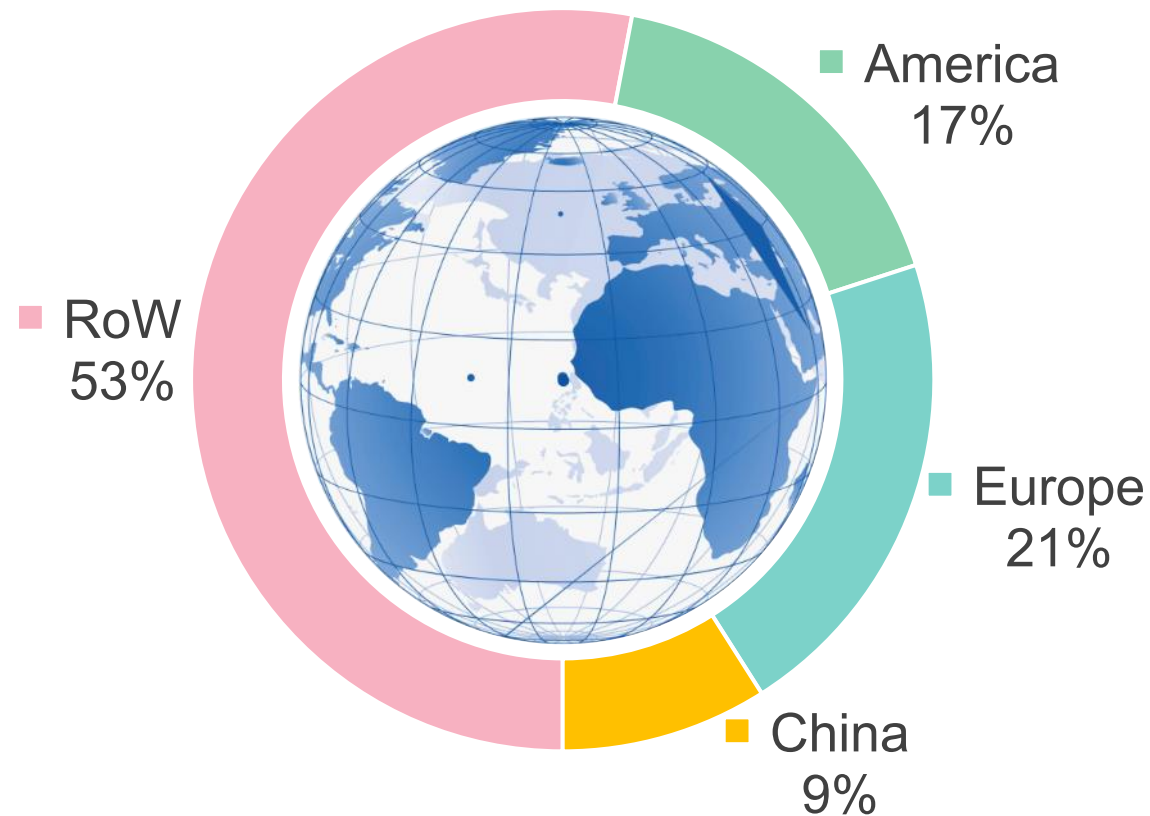

FSP Revenue FY2023 - FY2025 Q1

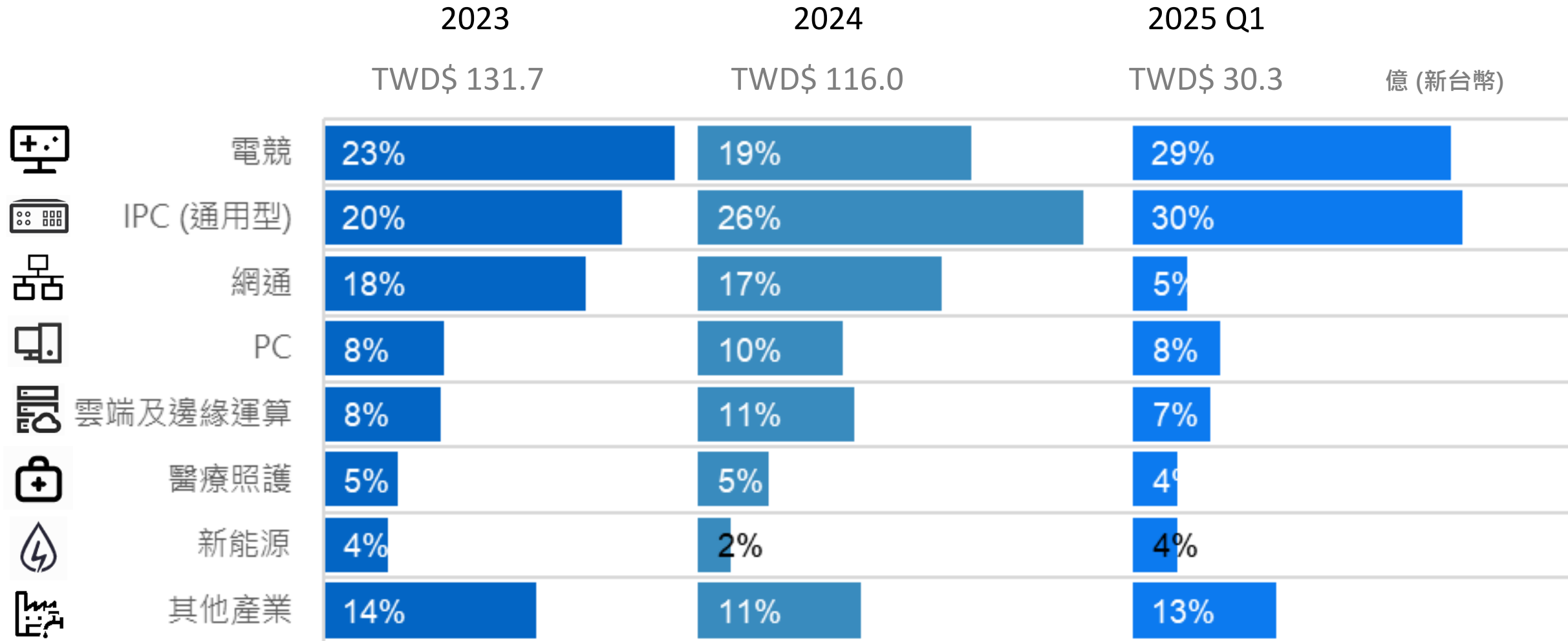

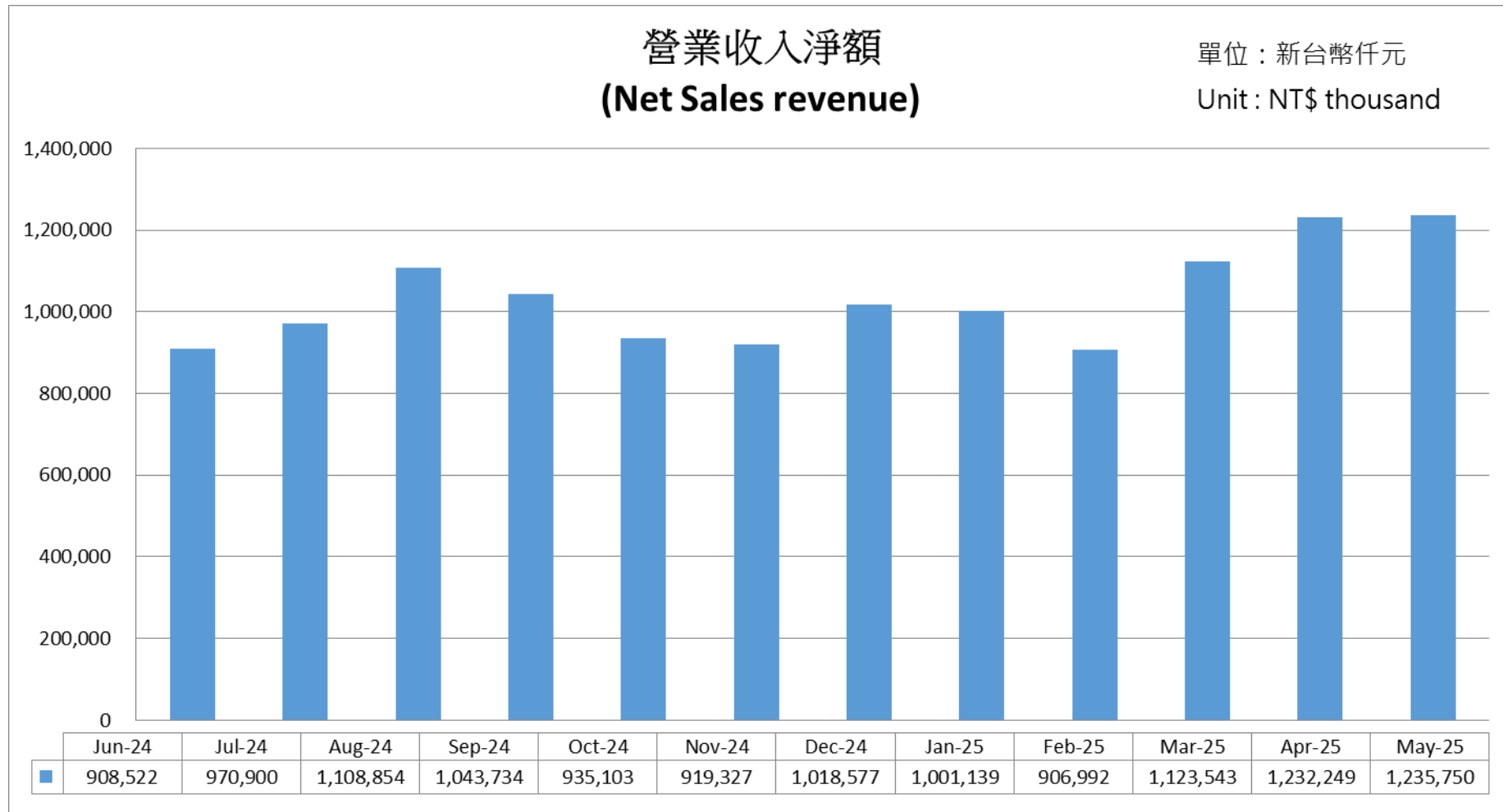
